6.1. CEO Report – Stephanie Hall

a) Branch Updates

Keremeos Branch & Letter from RDOS re Funding, dated April 13, 2107

A \$9000 funding reduction will result in a staffing hour reduction from 60.5 to 53.5 per week. Some additional staffing will be provided during the busy summer season and, based on public feedback, open hours will remain unchanged.

Peachland Branch

Due to an incident on April 5 that caused substantial damage to the building, the branch and book drops remain temporarily closed for repairs. Late fees are being waived and requested items are being sent to the Westbank branch. A follow up press release will be issued.

Silver Creek Branch

Discussion was held in-camera and brought out to the open meeting.

A community survey conducted in February and March indicated a strong support for having a local branch. School District #83 is prepared to continue maintaining and leasing the building to the ORL, though Interior Health Authority has issued a water quality advisory and has asked the school district to address the issues in order to allow the building to remain open.

In accordance with the ORL's FAMA model, (Financial Allocation Model Analysis), the branch is slightly overserved and currently slated for a reduction in staff hours. Numbers will be reviewed over the summer and targets will be revisited, followed by discussions with local government and a community consultation. These processes are similar to those the ORL has followed in other communities.

The meeting recessed at 10:38 AM The meeting re-opened at 10:52 AM

b) Strategic Planning / 2017 Operational Plan

At the November meeting, the Board signalled that the second strategic direction in our strategic plan "Our library is an integral part of life in our diverse communities", will be the priority in 2017.

Staff shared an operational plan draft document entitled 'Working Priorities', and the Board were invited to comment. If there are no changes received within a week after the meeting, the Working Priorities document will be finalized and shared on the ORL's website.

c) 2016 Annual Report

Date:	September 14, 2017

Both motions (excerpted below) call for a restoration of provincial library funding as a proportion of overall revenue for public libraries to 1986 levels. This would mean provincial funding would become 21% of our funding and would increase provincial funding from around \$14 million annually to over \$51 million.

These are the only library funding motions on the table at present for UBCM 2017.

I talked to the CEO of the Vancouver Island Regional Library, and while Ladysmith is the municipality bringing it forward, it sounds like it has the full support of their board.

I am asking that board members consider supporting these motions at UBCM and have prepared some talking points as well, along with a letter to the Minister.

B60 Restoration of Previous Provincial Funding Levels for Public Libraries

Powell River City

Whereas the Ministry of Education, Library Branch completed the "Inspiring Libraries, Connecting Communities" vision and strategic plan which:

"focuses on enabling libraries to deliver the connected and innovative services, programs, and information resources that British Columbians need now and will need in the future. The vision also recognizes the important role libraries play in enabling equitable access to information. People will have access to the information they need regardless of who they are or because of any physical or geographical barriers;"

And whereas the Province recognizes that "public libraries play a key role in welcoming newcomers and job seekers in British Columbia," and provides "British Columbians with access to the information and tools they need to learn, work, create and thrive in today's changing world" in "safe, open spaces for people of all ages and backgrounds;"

And whereas provincial funding for public libraries has decreased from 21 per cent of total revenue in 1986 to five per cent of total revenue in 2016;

And whereas in order for public libraries in British Columbia to remain current, relevant and accessible to all, municipalities and regional districts have had to increase contributions while their capacity to continue to do so is severely limited and tenuous:

Therefore be it resolved that UBCM call upon the provincial government to restore funding for the public library system to a level of 21 per cent of the core annual budget required to operate the British Columbia Public Library System in an efficient, effective and equitable manner.

UBCM Resolutions Committee recommendation: Endorse

UBCM Resolutions Committee comments:

The Resolutions Committee advises that the UBCM membership has not previously considered a resolution calling on the provincial government to provide funding for public libraries equivalent to "21 per cent of the core annual budget required to operate."

However, the Committee notes that members have consistently endorsed resolutions calling on the Province to maintain and index its funding for public libraries (2016-B95, 2014-B17, 2012-B71, 2011-B27, 2010-B46, 2008-B57, 2007-B56, 2006-B55, 2006-B56, 2002-B13, 2000-B28, 1999-B13, 1996-B82).

Resolution 2011-B27 in particular asked the Province to restore funding for libraries "to the levels that were achieved as part of the strategic plan prior to 2009."

In response to resolution 2011-B27, the provincial government observed that it had maintained funding for the public library sector at \$14 million in 2011, which was "60 per cent more funding than in 2001." The Province also suggested that implementation of the public library strategic plan "Libraries Without Walls" had "generated substantial economies of scale, enhanced the stability of libraries and improved organizational infrastructure."

C4 Provincial Funding Levels for Libraries

Whereas the Vancouver Island Regional Library is the fifth largest library system in British Columbia, serving over 430,000 people on Vancouver Island, Haida Gwaii and the Central Coast (Bella Coola) through 39 branch libraries, an e-Library and books by mail service;

And whereas the Vancouver Island Regional Library's focus has dramatically changed as our society has changed through technological advances in order to remain relevant, while the level of provincial funding has decreased from 21 per cent of total revenue in 1986 to five per cent of total revenue in 2016, leaving its member municipalities and regional districts to bear the increases through increased contributions while their capacity to continue to do so is severely limited:

Therefore be it resolved that UBCM call upon the provincial government to restore funding for the public library system to a level of 21 per cent of the core annual budget required to operate the library system in an efficient, effective and equitable manner for the local government taxpayer.

In a Nutshell

- Public libraries operate a network of community service points across the province
- Libraries are adapting to new roles, supporting skills development, tech literacy, and education in communities
- There is a massive opportunity for government to capitalize on these learning activities to support economic and social development
- This government has an opportunity to advance a progressive agenda through re-instating funding levels to public libraries

Impact of Provincial Funding

- Supports operation of all public libraries in BC and is important to all of them, from urban to remote
- Provides extra support to rural and small community libraries, which is critical to their survival

- Provincial Library funding has been frozen since 2005; accounting for inflation, this amounts to a 19% cut
- Meanwhile, the service population across BC has increased over the period by 10%



Dear Minister Fleming,

On behalf of the Board of Trustees and staff of the Okanagan Regional Library, please accept our congratulations on your new appointment as Minister of Education. Your portfolio is a large and important one, with many needs and opportunities. This letter aims at sharing a few of those needs and opportunities in the public library sector in British Columbia.

First, let us start with the opportunities.

- **Public libraries are well connected in communities, and are natural partners.** Most library systems have anywhere from dozens to hundreds of formal and informal partnerships with other community agencies.
- Public libraries touch the lives of over 2 million British Columbians each year, with 47% of the
 population being registered, active users. Public libraries offer 247 in-person service locations
 across the province, and a host of online services, like free downloads, Lynda.com training, and
 much more.
- Public libraries have enormous public support, as the government of Saskatchewan recently discovered when many thousands of local people from all walks of life took to the streets of communities small and large to protest proposed cuts.
- Public libraries provide an increasingly diverse array of facilitated, self-directed, and peer learning opportunities that support people as they re-skill and enrich their knowledge and abilities. As we look at the reality of projected job changes due to automation and other factors, we see that a population that is supported in rapid adaptability to new requirements is vital to economic stability and growth.
- Public libraries support the acquisition of digital and tech skills for all ages
- Public libraries have a long history of supporting ordinary working people, families, and the most vulnerable people in our society

On the topic of what government can do to support the work and community benefits of public libraries, there are a few main points.

Remove the 10+ year freeze on provincial public library funding levels that has been eroding library service, particularly in small communities. We support the 2017 UBCM motions from Powell River and Ladysmith to restore previous funding levels or a similar bump. Provincial funding in BC was formerly 21% of library revenue, which went a long way to enabling equity of service across the province and enabling libraries to support provincial priorities.

- To put this in perspective, if funding levels had remained consistent as a proportion of funding from 1986 on, in 2016 the province would have invested just over \$51 million annually in support over 2 million active library users, self-directed learners who are working on both their own development and the well-being of communities.
- Support strategic priorities of the Provincial plan and take an active interest in how public libraries can support the learning objectives of the province. Sometimes, rather than creating a parallel infrastructure for a new initiative, it may make sense to work with and through the massive, connected, and much loved public library sector, which is a shared initiative of local, regional and provincial governments.
